

## 1. Postgraduate Programmes accredited towards the FGDP(UK) Career Pathway

Participants who have presented cases as part of a programme's final assessment may be eligible for a full or partial exemption from the case component of the FFGDP(UK) assessment. Programmes that carry a case exemption are indicated on the list below. Participants should note that case exemptions are valid for seven years after completion of the programme.

- Overseas qualifications may also be considered, provided they meet the same set criteria for accreditation as UK based programmes.

## 2. CPD Courses accredited towards the FGDP(UK) Career Pathway

Under new FGDP(UK) accreditation regulations CPD courses which meet the appropriate criteria can be accredited towards the 'other' credits component of Stage 2 of the FGDP(UK) Career Pathway in. **Applications for accreditation of CPD courses towards the Career Pathway can only be made by course providers. Career Pathway participants may transfer a maximum of 20 'other' credits from accredited CPD courses to the Career Pathway.**
